The Nominating Committee is presenting a slate of new officers for vote that represents Glenkirk in terms of ministry involvement, age, and gender. Glenkirk's bylaws permit covenant partners to make a "nomination from the floor" during the congregational meeting where new officers are voted on. This means that a covenant partner may challenge the slate that is being put forth by the Nominating Committee by adding another name.

Any floor nomination must to be submitted in advance to the Glenkirk office by August 11th. This will allow the Nominating Committee to contact the individual, inform them of the requirements for the office, and ask them if they wish to serve. If the individual wishes to have their name put forth, on the day of the congregational meeting their name will be added to the ballot and the covenant partners will vote on those individuals they wish to serve as officers. (For example: there are 7 positions open for elder and one youth position that is for one year. If a name is added 8 names will appear on a ballot with covenant partners being asked to vote for 7. The seven with the most votes will be elected). If there are no nominations from the floor the slate presented by the Nominating Committee will be voted on as a whole.
